## 5. Subcommittee Updates:

## a. Subcommittee 1 – Technical and Conference Publications (Masson)

- 1 RREC Presentation is going to AREMA Conference as a presentation
- There are 3 environmental presentations this year at AREMA! Really big deal.
- Goal is to get even more presentations to AREMA Conference 2023.
- C13 will send out list of C13 members that are presenting at AREMA 2022 Conference in Denver ahead of conference.

## b. Subcommittee 2 – Education and Training (Hill)

- Focused on articles and presentations promoting C13
- Currently looking to get a few articles into railroad publications like RT&S (ties with AREMA)
- Martina led RTS August 2021 Article
- Reached out to RT&S about potential C13 article. Waiting on guidance from RTS on if the topic should be high level about environmental topics, or more detailed.
- Have subcommittee meeting on June 1st.
- Part 1 (2021 and March 2022) and Part 2 (April 2022) Webinars that Kari presented on went great. Good Q/A and some good feedback.
- Will connect with past RREC presenters to see if they want to do RT&S articles
- Contact Alayne with AREMA to get publisher's info?
- Prepare a short presentation to use to promote joining C13 that Kari can present at other Technical Committee meetings.
- Michael Potter (via Teams chat): Possible articles/presentations/issue updates to work on with other committees:

- Plan to engage with AREMA student chapter at RREC to possibly take over for them at
  the registration tables periodically in order for them to be able to attend some of the
  presentations and/or seat students at tables with railroad professionals at the AREMA
  dinner again. Kelly will reach out to Chris Barkan to see if this is possible.

# d. Subcommittee 4 – Chapter Review (Williams, Dorsey, Hattenberger)

- Met March 15<sup>th</sup>.
- Only two sections are outstanding Introduction and Appendix.
- 7 years is considered out of date. 5 years is the ideal minimum update frequency.
- Doug Dorsey and Sue Hattenberger working on updating the Introduction.
- Matt W. working on updating the Appendix.
- Next section that will be due is Air Quality (last updated in 2019).

- Kari and Peter are working with Karla Graf, France Moreau and Craig Fisher to develop the Canadian Part, which should be finished and ready for a vote this summer

   Committee 13 chapter of the AREMA Manual
- New Subcommittee 7 Due Diligence Part, created. Group confirms new subcommittee and topic. Mark Bergeron and Coley Campbell to be primaries for new subcommittee and re-write.

- If we want new section (Transactional Due Diligence) to be included in 2023 version of AREMA Manual, it needs to be in by November.
